Comment: Visited CM today to complete FEEE approval - however there are still some actions to be completed.

Comment: Called CM to follow up on 2 remaining actions on FEEE compliance form. She has lost her husbands DBS and is waiting for him to call them for a copy. Gas check has yet to be booked.
