- Do I need to review my admissions policy? What models of delivery can I operate?
- How long or short can sessions be?
- How much will I be paid for the FEEE hours that I provide?
- How do I ensure that I meet my statutory duty to ensure that invoices and receipts are clear, transparent and itemised allowing parents to see that they have received their child's free entitlement completely free of charge and understand fees paid for additional hours or services?
