Date uploaded: Wednesday, 1 November, 2017

Comment: CM called and advised that she only has one EY child on a Friday.

Comment: CM called to advise that she has a 4 year old starting on Tuesday who is eligible for FEEE. Vira advised her to ask me for support with the headcount form..... I advised CM to sign the contract with the parent, and ask parent to fill in the parental declaration form (directed her to the HUB). CM is going to call me on Tuesday to go through the Headcount form over the phone.
